TYPE OF INVESTMENT

- **€500,000** The acquisition of real estate. You can buy one or several, any type of property, but the total amount of investment has to be a minimum €500,000.
- **€1,000,000** Buy shares in a company or deposit funds in a Spanish bank.
- **€2,000,000** An investment in government bonds.
- **Creating project** An Investor needs to start a business project, and provide jobs, social & economical impact and be of scientific or technological interest.

WHO CAN APPLY

Requirements for an investor:

- Any citizen of a non-EU and EFTA country.
- Age above 18 years old.
- Clean criminal record.
- Medical insurance.

Eligible family members:

- Spouse or unmarried partner.
- Children under 18 years.
- Adult children, who are not married, as well as students.
- Parents over 65 years old and supported by one or both spouses.

BENEFITS

- **Free travel in EU.** Golden Visa allows its holder to visit the countries of the Schengen area without obtaining additional visas.
- **No requirement to stay.** You are not obliged to visit Spain every year to keep your Golden Visa.
- **Spanish Passport.** You can apply for Spanish nationality if you have Golden Visa for 10 years and you reside in Spain at least 183 days per year.
- **Opportunities.** You and your family have the right to live, work and study in Spain, a country with social and political security, and economic opportunities.



STEPS FOR SPAIN GOLDEN VISA

1 STEP

Choose the right type of Investment, and find a lawyer who will do the paperwork. Make the investment. You can visit Spain to choose a property, but for this you need to apply for Tourist Visa first.

2 STEP

Submit application for residency visa to the nearest Spanish Embassy or Consulate. It gives you the right to live in Spain, Visa is valid for 1 year.

3 STEP

Submit application for a residency permit. You need to visit Spain for submitting biometric information. First Visa is valid for 2 years. There is no minimum stay requirement to keep Golden Visa.

4 STEP

After 2 years you can renew your Spanish residency card for 5 years. You must maintain your investment. You can change the type of investment, but the total amount has to be as required.

5 STEP

After 5 years or residency permit, you can apply for a permanent long-term permit. There is an additional requirement for this type of permit, living in Spain.
